# **Snow Go Program**

Need help clearing your driveway and/or walkway during the winter?

The Snow Go Program can help you! This program is divided into two parts to match your individual needs to the appropriate service. The two programs are as follows:

- The Snow Go Program provides a matching service for seniors and people with disabilities looking to hire an individual or contractor to clear snow from private driveways and walkways. Residents who participate in this program are responsible for paying the individual or contractor removing the snow.
- The Snow Go Assist Program provides financial assistance to eligible low-income seniors or persons with disabilities looking to hire an individual or contractor to clear snow from private driveways and walkways. Approved participants may be reimbursed for 50 % of the cost of snow clearing per event, up to a seasonal maximum of \$250. Rural applicants who have excessively high cost of snow removal, as defined by staff, are eligible up to 50% of the cost of snow clearing for their private driveways and walkways per event, up to a maximum of \$450 per Term.

Update to the All Terrain Vehicle Trail Network Pilot Project in Osgoode Ward In 2013 the City of Ottawa approved <u>Temporary By-law 2013-199</u><sup>1</sup> to allow for a pilot project for all terrain vehicles (ATV) usage on selected municipal roads and road allowances in Osgoode Ward.

City Council, at the recommendation of the Agriculture and Rural Affairs Committee, has amended the bylaw to extend the expiry date to November 30, 2017 to allow for a proper review of the impacts of the trail network. In addition, the by-law now permits additional types of vehicles that are permitted under provincial legislation, including "two-up" ATVs, side-by-side vehicles and utility terrain vehicles.

# Permanent Signs on Private Property By-law Review

The City of Ottawa is reviewing the Permanent Signs on Private Property By-law 2005-439. Permanent signs identify buildings or properties, provide information on occupants or services offered at particular locations, advertise goods or services, or provide directional information.

The current By-law dates back to 2005 when the sign by-laws of the eleven pre-amalgamation municipalities, townships and villages that comprise the new City of Ottawa were consolidated.

Although there have been tweaks and technical amendments to the By-law since then, it is now time to take a broader view to make sure that signs in Ottawa meet key objectives for signage and that the By-law reflects emerging technologies and trends.

Three objectives for signage have been identified. These are outlined in a discussion paper that elaborates on each and which seeks public input on key questions.

- Public Safety the design, location, maintenance, and operation of signs should not pose a safety hazard for drivers, cyclists, and pedestrians.
- Good Design and Fit signs should be compatible with their surroundings, reflect the City's overall planning and design objectives and contribute positively to a liveable built environment.
- Economic Development signs should contribute to the economic well-being of businesses and communities and assist wayfinding.

# Commemorative Naming Proposal: Allen Sadler Fire Station – (Ward 21 – Rideau-Goulbourn)

In recognition of Allen Sadler's extensive community service, the City of Ottawa has been asked to rename the Ottawa Fire Station #83, located at 2352 Roger Stevens Drive, the "Allen Sadler Fire Station".

A summary of the proposal, submitted by Joe McLaughlin, is provided below:

Allen Sadler has served the community of North Gower as a volunteer firefighter since 1965, receiving his 50 years of service award in 2015. He serves as a role model for younger firefighters and is known amongst his colleagues to be dependable, approachable and always willing to answer questions.

In 2005, Allen was recognized as the Station 83 Firefighter of the Year, an award that is voted on by all members of a fire station, and in 2014 he received the District Firefighter of the Year award.

In addition to serving his community as a volunteer firefighter for 50 years, Allen Sadler is also known as a pillar of North Gower's business community, owning and operating P.O. Sadler & Son, a company founded by his father in the late 1930s.
